Introductory note

This introductory note does not form a part of the permit

The main features of the permit are as follows.

This licence permits the holder to operate a Household, Commercial and Industrial Waste Transfer Station with waste treatment at the specified location. The inputs are limited to non-hazardous and inert wastes and do not include hazardous wastes such as asbestos. Wastes of similar types will be transferred into larger containers and sent to other waste facilities for further treatment, recovery or disposal. Wastes can be bulked up for disposal or recovery elsewhere and also can be treated by sorting, separation, screening, baling, shredding, crushing and compaction of waste. This licence does not permit the burning of any wastes, either in the open, inside buildings or in any form of incinerator

This licence does not allow any emission into surface waters or groundwater. However:

- Liquids may be discharged into a sewer subject to consent issued by the sewerage undertaker.
- Liquids may be tinkerered off-site for disposal or recovery.

Clean surface water from roofs, or from areas of the site that are not being used in connection with the storage and treatment of waste, may be discharged directly to surface waters, or to groundwater by percolation through the soil via a soakaway
