Infrastructure

There was no evidence on this occasion of waste on the wall that separates the top loading area from the bottom loading area. It is understood that plans are in place to improve the loading of waste and Powys County Council are currently awaiting work to be undertaken by a third party.

Commencement of mixed municipal waste

The new building has been completed but is not yet accepting municipal waste. Please inform Liz Park when the bulking up of mixed municipal waste commences.

Site diary/ daily check sheets

The daily check sheets were checked and are being completed. No issues noted.

Odour complaint

An odour complaint was received by Natural Resources Wales on 4 January 2017. Gary Amor was contacted by Liz Park. The odour may have been the result of an additional food collection being required following Christmas. No odour was noted by the site following the daily odour testing. Additional checks for the next couple of days were agreed following the odour complaint.
