## 4. Details of our assessment

Waste returns for September to December 2021 have been reviewed for Gofer Bulking Station, permit number EPR/HP3591EZ.

### G4 Reporting and Notification to Natural Resources Wales

Historically the site has operated under the permit EPR/HP3591EZ in combination with a T4 and S2 exemption. Mixed municipal waste 20 03 01 is not acceptable under a T4 exemption. As this waste code is not acceptable under the exemption it should be recorded in the waste returns for the permit. Waste code 20 03 01 has not been recorded.

A **category 4** permit breach has been applied with respect to permit condition **4.2.2 “Within one month of the end of each quarter. The operator shall submit to the Environment Agency using the form made available for the purpose. The information specified on the form relating to the site and the waste accepted and removed from it during the previous quarter”**.

**Action:** Include waste type 20 03 01 in future waste returns.

### C3 Waste Acceptance

It is known that the site is accepting comingled plastic bottles and trays with steel and aluminium cans which is coded as 20 03 01- mixed municipal waste. This waste code is not permitted under HP3591EZ.

A **Category 3 breach with respect to permit condition 2.3.2(a) “Waste shall only be accepted if it is of a type listed in schedule 2 table S2.1” has been applied.**

**Action:** Apply for a permit variation which would allow for all site activities under one permit without the requirement for exemptions.
