Compliance with Directly Applicable Legislation. Category 4 breach.

The site has been scored a category 4 breach for non-compliance with Regulation 13 (1) of the Waste Regulations (England and Wales) 2011 as amended for not providing a separate collection for your paper, plastic, metal and glass and/or not providing a necessity (TEEP) test as to why this would not be possible on site. Please see the letter attached for further information on the requirements of this legislation.

Details of the visit

Waste is brought onto site in a co-mingled form although separate waste collections are offered to some customers such as cardboard collecting. Mixed waste is deposited in the building on site then some waste types are picked out, mainly cardboard and paper. The majority of waste is stored on site before being transferred to another site for treatment.

Currently, Thomas Waste are taking the waste from site in a co-mingled form and are therefore not compliant with the regulations. I explained to Gareth that although we were not taking enforcement action at this time we will be enforcing the regulations in the future and in which case the relevant processes need to be put in place. As discussed on site, 'regulation 14(1) of the Waste Regulations 2011 as amended, once the four waste materials for recycling have been separately collected, the regulations require the materials to be kept separately and not mixed with other wastes or other materials with different properties.' This is being done on site and when available they are moved to the relevant site. We discussed the TEEP test and why this would need to be applied if the waste was not to be collected separately. The site would need to prove that it was not technically, environmentally or economically practicable to collect the waste in separate fractions, or again this would be noncompliance with the legislation.
