A site inspection / site handover was carried out by Neil Griffiths and Lara Moggridge. Gareth Thomas walked around the site with us during the inspection.

The weather was cold, with showery rain at the time of the inspection.

A1 Specified Activities: Category 3 Breach of Permit condition B1.1

Several skips full of waste were being stored off site, across the road from the site entrance. A temporary solution needs to be agreed to prevent this recurring permit breach.

Gareth Thomas expressed an interest in acquiring other sites in the area in order to provide more space for the storage of waste. Neil Griffiths agreed to make some enquires about this and get back to Gareth.

A new concrete pad had been laid in the waste sorting area at the top end of the site. This was good to see and it had improved the conditions on site.

The interceptor inspection chambers were accessible at the time of the inspection which was also good to see. The interceptor was inspected and it appeared to be working well. The stream that the interceptor discharges into was running clear.

No other issues were identified at the time of the inspection.

Neil Griffiths will now be responsible for regulating the site.
