C3 Material Acceptance - 2017 Waste Returns

The submitted 2017 waste returns have been reviewed and it has been noted that the site has reported receiving waste types, which are currently not permitted under **condition 2.3.2 (a)**. **The following waste code: 02 03 03** (Accepted in Q1 of 2017).

**** Evidence has been submitted to show that this was an administration error. Previous non compliance score has been removed.**

C1 Staff competency/training

Under condition 1.1.1 (a) the site is required to operate in accordance to an EMS which identifies and minimises the risks of pollution, including those arising from operations, maintenance accidents, incidents, non conformances, closure and those drawn to the attention of the operator as a result of complaints.

For this, Work Instruction WI 82f was reviewed. This document makes up part of a larger document set and identifies the controls and emissions for a specific site activity as well as highlighting what should be done if an incident occurs.

Under condition 1.1.1 (b) the site must use sufficiently competent persons and resources. Training documents were provided and reviewed on site during the inspection for a member of staff.

F1 Odours

No odours were detected outside of the reception building.
