A spillage of waste occurred at Grosmont Wood farm whilst pumping waste poultry washings from the transport lorry into storage lagoon. On arrival at scene by NRW employees who were passing it was observed that a large amount of waste was flowing down the road (photographs obtained). The NRW employee spoke to the driver of the lorry who was trying to clear waste from the road. Having spoken to the driver it was clear that the incident had not been reported and a correct clear up procedure had not been commenced.

I have recorded a breach under A1 failed to comply with condition specified in permit

Breach of condition 4.3.1 states that Natural Resources Wales shall be notified without delay following the detection of

(a) any malfunction, breakdown or failure of equipment or techniques, accident, or emission of a substance not controlled by an emission limit which has caused, is causing or may cause significant pollution.

There is a requirement to improve procedures to ensure that correct persons are notified as required and correct clean up procedure is adopted.
