The content of this CAR form was covered in an email to the operator dated 28/11/2018. Smoke was observed deriving from the compost on site (Photograph 1) and it was evident that there was a hotspot smouldering within the northern side of the stockpile (closest to the MRF). There was an umbilical pipe laid near this hotspot and the operator advised that measures have been undertaken to put water on this. Operator should prioritise this area to ensure the hotspot is dealt with safely and appropriately and to ensure that there is sufficient separation distance between the hotspots and the remaining material on site.

NRW are concerned about the above matter and the operator must keep us regularly updated on this matter.

The operator on the 7th December 2018 updated NRW providing temperature data for the composting activity and advising that there is now no evidence of combustion and that your continuing to monitor.

NRW were not informed of this incident as required by permit requirements 4.3.

Please note that permit condition stipulated that the NRW should be notified without delay of the detection of failure of techniques, accident or emission of a substance not controlled by an emission limit which has caused, is causing or may cause significant pollution.

NRW were not informed of this incident and therefore a **CCS3 score of 3** is applied under condition 4.3 of the permit.
